Appendix 20. Timetable to update the SHMA

A20.1 Introduction

Each year, various returns are completed by district and county councils, by planning departments, housing departments and Registered Social Landlords. This secondary data is invaluable when updating a suite of data like the SHMA and the CLG guidance encourages reference to, and use of, such secondary data sources.

This annex sets out diagrammatically, the sources of data used, the dates they are based on, their submission or publication dates, and how they feed into the SHMA updating process. It also sets out an annual plan to ensure that in future years, SHMA data is updated and feeds into a new draft set of chapters for consultation, alongside consultation events, to keep the SHMA partnership fully informed and involved.

A20.3 Irregular, one-off and ad hoc updates

New development surveys – programme to carry out surveys of significant new developments each year to add to our understanding of who moves in to which kinds of homes (particularly comparing household size and number of bedrooms) amongst other issues.

Stock condition surveys – information gathered by districts, as and when according to each one's plans, priorities and resourcing.

Population estimates by CCRG (most recent 2007).

Census 2011 – release due in 2012 or 2013.

Orbit reports on intermediate tenures – ad hoc once data has been uploaded to the new computer system, initiated in 2009. Once in place plan to gather data from Orbit in March each year.

Survey of English Housing – changing and combining with the English Home Condition Survey from 2009/10 onwards. Anticipate results for 2008/09 by mid 2009/10.

Other surveys – for example EERA's market conditions survey, HCA's Housing Market Bulletin, Insight East data

A20.5 Annual process - future

In future we aim to embed a regular timetable for updates, assuming the SHMA project continues as per the partnership arrangement currently in place, and subject to the resources continuing to be made available.
